The proposed development would increase the likelihood of flooding.

- Difficult plot shape

### **P247 Salting of Roads**

Consideration was given to the impact of Somerset County Council's winter gritting / salting regime

Issues raised during consideration and discussion of this agenda item included:

- this item was put on agenda as there is lots of local concern about the County Council's new salting regime
- Getting children to school when roads have not been gritted is a problem if the roads are considered too dangerous for school buses surely it is also too dangerous for private vehicles
- The road between Seavington St Mary and Ilminster is a main route if there is an
  accident on the A303; if there is such an accident, and in bad weather the
  likelihood of an accident increases, then cars will be directed on a diversionary
  route that is an ungritted road
- It is important to grit pavements as well as roads; In Ilminster most of the routes leading to the town centre are on hills so pavements need to be treated in order for people to walk into the town safely
- South Somerset District Council Street Scene did grit on pavements in the town centres of Yeovil, Crewkerne, Chard and Ilminster last week when the ice and snow was predicted

 The Town Council's emergency contingency store was opened and as a result Blackdown View was cleared and gritted by residents and de-icing material was provided to Victoria Court

**RESOLVED** that a letter is sent to Somerset County Council stating the Town Council's concerns about the level of gritting in and around Ilminster, particular mention to be made of Sea bends and Listers Hill.
