Speaker 1-

The speaker raised issues regarding Bins, the potential closure of Chard Minor Injuries Unit, Public Transport issues and a planning enquiry

The speaker stated that he had been approached by a trader in town regarding wheelie bins in Wharf Lane and Ditton Street being left on the path and causing an obstruction. He feels this is unsightly for the town and asked if the Town Council would be able to write to SSDC regarding this matter.

He also commented on an issue whereby a neighbour had installed a 4' by 3' window and had written to the planning department at SSDC regarding this but was yet to receive a response, the chairman suggested that this may be a matter for Building Regulations rather than Planning.

The speaker also commented on the potential closure of Chard Minor Injuries Unit and the impact this would have on people, given the difficulties of using public transport to get from Ilminster to South Petherton. This is outside of the Town Councils jurisdiction. There is a meeting to discuss this.

Finally, the speaker raised the issue of public transport and highlighted the demise of the Nippy bus. In the 27 months prior to it ending the speaker found it was used by 39,800 passengers. He raised the issue of a lack of connecting routes to other towns in Somerset and problems with bus timings.
