FUTURE OF LOCAL GOVERNMENT IN SOMERSET

DIARY DATE – 7TH October – Somerset conference for parish/town clerks and Chairs, to consider the principles on which Local Community Networks may be developed. and to include discussion around asset and service devolution as required.

The Local Government Review Advisory Board had been convened. Leaders and CEOs of all councils have met several times, and I am informed that good progress is being made. Anyone wishing to receive the programme implementation timetable please contact me.

Earlier this month, Michael Gove was appointed Secretary of State for Levelling Up, Housing and Communities and Minister for Intergovernmental Relations (formerly the MHCLG), replacing Robert Jenrick.

In the wake of the decision for Somerset to become a unitary authority, a direction was received for consideration of a boundary review. In addition to the very short timescale given, misgivings over this request were strongly expressed by the leaders of all five authorities. The final decision is awaited.

Somerset Youth Parliament: Nominations are being sought from young people aged 11 to 18, who live in or attend school or college in Somerset, wishing to become a Member of Youth Parliament (MYP). Nationally, over 300 elected representatives work with government to make sure young people's voices are heard. Supported by SCC, Somerset MYPs campaign on a range of issues, advise, represent, give grants and are consulted by decision makers. This short online form www.somerset.gov.uk/myp should be completed by Fri. 5 Nov. Elections will take place in Dec. 2021 with newly elected MYPs taking up office on 1 Mar. 2022 and serving a two-year term.

COVID UPDATE

The Somerset Growth and Recovery Plan has been developed in four stages: Lockdown; Recovery: Revitalise: Grow, and linked to these themes:

- employment skills and economic inclusion
- helping businesses and sectors to grow
- providing the infrastructure to enable growth
- creating attractive places and homes

DEVON & SOMERSET FIRE & RESCUE SERVICE (DSFRS)

The service is currently being inspected, and this will continue until the end of Oct. Some of the many areas of progress since the last inspection includes: Public focus – change to Service Delivery Operating Model consulted on and implemented. Improved emergency response standard performance has increased Prevention - established a Community Safety Strategy system to better identify levels of vulnerability and required interventions. Introduction of multiple resources to deliver prevention activity in different ways, with increased partnership and collaborative working.

SW EMPLOYERS PANEL

I once have again been appointed as Vice Chair of this panel. Pay agreement for council workers, schools, health workers etc. remains under consideration.

In The Municipal Journal Excellence in People Achievement Awards 2021, SCC was the winner of the Delivering Better Outcomes Award, in addition to being winner of the Best Talent Programme for their joint initiative with Yeovil College to 'grow your own Social Workers', and being Highly Commended for the Best Creative Concept Recruitment Campaign and Public Sector Team of the Year.

HEALTH SERVICES

Local residents are encouraged to engage with the team working on changing the way that health and care services are delivered across the county. Part of this initiative is to consider a new model of community care and same day urgent care, with a view to providing services closer to home, whilst also supporting personal independence and maintaining your own health.

The government has launched a six-week consultation seeking views on plans for staff in health and care settings in England to be required to have COVID-19 and flu vaccines to protect vulnerable people. It would mean only those who are fully vaccinated, unless medically exempt, could be deployed to deliver health and care services. The consultation will also seek views on whether flu vaccines should be a requirement for health and care workers, with a final decision expected this winter. SSDC OFFICER CONTACT & AREA MEETINGS

Concern continues to be raised over the difficulties faced by local communities in making contact and receiving timely responses from officers when issues are raised. One of the key challenges in raising matters via online forms is that they frequently fail to offer the options required. I have made the CEO aware of this, particularly in relation to some areas of service provision.

SSDC FULL COUNCIL

Following this month's meeting, the criteria for energy grants being made available were agreed. The current scheme is the Local Authority Delivery Phase 2 (LAD2), being delivered through the SW Energy Hub by Happy energy and EON. The main criteria are

- Grants are a maximum of £10,000 for owner occupied properties or £5,000 per rented property to improve energy efficiency.
- For rented properties there is a requirement for the landlord to pay at least a 1/3 of the total cost of works.
- The property must have an EPC rating of D or below (50% cap on D rated).
- Owners/tenants must be on a low income (below £30K per annum)

PLANNING

Concern has been raised by several parishes in relation to the shift to online notification of planning applications, rather than to provide paper copies. A number of village halls and other venues where PC meetings are held do not have internet access, which makes it impossible for applications to be discussed in full at their meetings. I have raised this and received the following response.

'Unfortunately, we are not going to revert to sending out paper copies of applications for several reasons firstly the officer time and cost involved with printing and posting all applications. Secondly the environmental impact and thirdly it was an agreed action from the Members Planning Reimagined Group. However, we are very keen to support parish councils in becoming more digitally enabled, whether this is by supporting with Wi-Fi, hardware or training. It is important to us that all parishes can access planning information to make an informed consultee statement.'

I have pointed out that not all venues will be willing or able to install Wi-Fi and have suggested that SSDC might consider financial contributions in support.

ENFORCEMENT

Reporting breaches of planning conditions to enforcement, and the lack of response, remains of concern to several parishes. I am informed that one of the reasons for this is the significant rise in the number of cases compared with 2-3 years ago. If action is not being seen in a particular parish it does not mean a case is not being pursued. This response was

'Cases should be logged via the website, which will then provide update emails from a no reply@ssdc email. The team are keen to avoid more than one point of contact which will result in a loss of the ability to control the route of communication; something that has deluged officers with chasers rather than trying to do the job at hand.'

SSDC ENVIRONMENT STRATEGY

There are now 68 champions across the district but greater representation in some areas would be welcome (in this area they are at Ilminster, Broadway, Donyatt, Ashill and Chaffcombe). You do not need to be a parish councillor to become a champion, and communities can have multiple champions covering different areas of expertise. Champions have been active in a variety of ways - accepting tree packs, nominating no mow spaces, participating in sharing events or providing content for Get Sussed. BUSES

As a result of a successful bid by SCC to the Dept. for Transport for one off funding to improve/restore some local bus services in Somerset, a new bus service (no. 18) began on Tues. 21st Sept. operating between Ilminster and South Petherton.

The service will operate two days per week, Tues. and Fri., providing three return journeys each day with the first departure from Ilminster and the last return journey from South Petherton connecting with service 81 to/from South Petherton Hospital at 0945 and 1245 for onward travel to/from Yeovil allowing a 1 hour 40 min. stay in Yeovil for shopping etc. The funding will support the service for at least 18 months (dependent on passenger uptake). SCC are planning to include all service improvements made with this funding in their National Bus Strategy, Bus Service Improvement plan, with a view to securing more long-term funding. If successful, days of operation will be increased over time. Timetable of the new service have been posted on the relevant bus stops.

The Somerset Bus Service Improvement Plan (BSIP) group had over 80 Councils and interested parties attend their virtual meetings this month. https://youtu.be/4H0700KIV4g BSIP are waiting to hear back from SCC as to the date of their next meeting. - 5. local people are encouraged to come forward to represent their area or their bus route.

WASTE COLLECTION/RECYCLING

Recent issues with regard to missed collection appear to have been largely resolved.

BROADBAND

I have now received an update to previous enquiries from Connecting Devon & Somerset (CDS), specifically relating to coverage in Dowlish Wake, and the ownership of a noncompleted Gigaclear installation.

My contact at CDS, Matt Barrow, has so far been unsuccessful in receiving further information from Gigaclear.

CDS had terminated their contract with Gigaclear in Sept. 2019 due to their continued failure to meet contractual obligations. In the case of Dowlish Wake, Gigaclear did not complete the promised network build in the area, resulted in them not receiving any funding from CDS, and any equipment, including ducting, cables, and other assets remain the property of Gigaclear, meaning that CDS has no say in how these are managed. In order to extend superfast broadband networks across the region, CDS has since signed contracts, in Dec. 2020, with three providers Airband, Wessex Internet and Truespeed. The Wessex Internet contract covers areas within rural South Somerset, but this does not extend to Dowlish Wake. Premises without superfast broadband that cannot be connected under this contract, may be eligible for the BDUK Rural Gigabit Voucher Scheme. More information me can be found on the BDUK website at Gigabit Vouchers (culture.gov.uk) Some residents did apply for Mobile Boost vouchers earlier this year, but due to the high level of demand, the project was paused in June. Additional technology options and suppliers have now been added to the project, to allow for more choice for applicants. I continue to wait for a response from Connecting Devon & Somerset (CDS) in relation to enquiries made by local residents who have concerns about

There have also been complaints about lids missing from Gigaclear Points Of Termination (POTs), that may cause an accident. Gigaclear contractors "installed" the POTs in the most convenient places, often with the tops raised above ground level. As a result, a number of lids are missing or have been damaged. Questions are being raised as to liability should an injury result.

A358 UPDATE

This month's meeting was well attended and affected parishes along the route are now in the process of signing off the latest proposals from the joint parish working group. One key area of concern that remains is the impact on traffic flow at the Southfields Roundabout and suggested actions which could improve this. At present it is felt that the level of importance to this area of the project is not receiving the consideration it deserves.
