- 23-0036-PHT Request for a bin next to the Orchard Vale bus shelter**
Members were informed that the Clerk would be discussing the future possibility of recycling and the collection of waste from public bins with Somerset Council on Friday 7th July 2023.
Members discussed different possibilities. Discussions included relocating an existing bin to the area of the bus shelter, the bin should have an ashtray on top, be usable for dog waste and to be small enough to keep seagulls out of the bin. Small bins may be able to be fitted to the bus shelter or posters like 'Keep Britain Tidy', 'Take your litter home' could be placed on the bus shelter negating the need for a bin. Whether the littering in that area is enough of a problem to warrant the purchase of an additional bin when there is one across the road and another outside of the library.
Members **RESOLVED** by 7 votes to delegate to officers to investigate the placement of a bin near the bus shelter and to bring information to the a Planning, Highways & Transport Meeting.
