Members **NOTED** the report from the Countryside Manager.

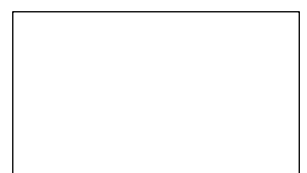
Members **NOTED** the tree safety works report.

Members were advised that there are no immediate concerns regarding
the oak tree near the cricket club but the tree will continue to be
monitored and the bench has been removed as a precaution.

The Countryside Manager updated members on the success of the 2
volunteering days that have been held so far. Tasks included preparing
a section of hedgerow which the volunteers will help lay in January,
removing plastic tree guards and restoring a dead hedge.

The wildflower meadow has been seeded, more seed has been applied
for from SSDC.

Any trees affected by Storm Arwen have been made safe by a tree
surgeon.



OS377 Letters to residents

Members discussed writing a letter to residents in the area of Shudrick stream as it has been noted that green waste is being dumped in/near the stream.

Members were advised that the Environment Agency had been out clearing the stream in recent days.
