to 400 dwellings with associated access. Location: Land South West
Of Canal Way Ilminster Somerset Applicant: Persimmon Homes SW
& Somerset County Council Application
- Members **RECOMMENDED** unanimously to object to the application
as they do not feel that the previous objections, below, have been
addressed. In addition, the emergency access is inadequate.
- There is a high density of homes with only one entrance/exit road.
Loss of prime agricultural land.
There are trees within the development that have TPOs on them*

One of the roads leading on to the access roundabout hasn't been adopted and therefore no give way/stop signs.

Can the roundabout support the increased volume of traffic.

Point of access is a key issue, no other development of this size within the town only has one point of entry/exit.

The impact on existing services and amenities within the town eg. doctors

Can the current drainage system in Ilminster support the new housing.

The balance ponds are not adequate.

Potential for increased flooding risk within the town.

Ilminster has flooded 5 times in the last 20 years.

Further clarification is needed on phosphates credit scheme and offset mitigation rights.

Every application is discussed on its own merit.

Members requested that the application goes to committee of Somerset Council.

No provision to build a new school and no consideration for children with disabilities.

Lack of upkeep on existing developments within the town have led to areas not being adopted.

- c 23/02363/HOU Proposed two storey rear extension to dwelling and retrospective planning approval for front driveway 2 The Crescent Ilminster Somerset TA19 0ER

Cllr Hamilton advised the committee that as the SSDC member at the time he had put the notification in to Somerset County Council at the time that SSDC still existed that he had concerns over the driveway's legality. He stated he would abstain from voting on the retrospective aspect of the planning permission.

Members decided to discuss the above planning application as 2 separate items.

The retrospective planning approval for the driveway was discussed first.

Discussions included some Members are not in favour of retrospective planning applications but understand that errors happen on applications and paved driveways need to be permeable to allow the water to disperse without seeping on to the pavement/road.

Members **RECOMMENDED** by 5 votes for and 1 abstention (Cllr Hamilton) to object to the driveway part of the application on the grounds that there is no suitable drainage plan in place therefore any water could encroach on the pavement or highway.

Members **RECOMMENDED** unanimously to support the application for the proposed two storey rear extension to the dwelling.
