Discussions included Somerset Council are carrying out research on comingle bins. The comingle bins can accept rubbish and dog waste, they are also seagull proof. Somerset Council are not actively looking to site any new bins. It is not a statutory requirement to provide rubbish bins.
A representative from Somerset Council recently visited Ilminster to note the location of the bins, if the larger comingle bins are required and if the locations will allow vehicle access close enough to empty the bins.
Officers are waiting for further updates from Somerset Council who are carrying out a charging review of public waste collections.
Somerset Council currently cannot deal with separated rubbish, everything is taken to the same incinerator site.

Discussions included there is no provision in the budget for the cost of requesting a change in speed limits, there is no enforcement provision, the speed limits are not obeyed, Central Government have indicated that they are against 20MPH speed limits.

If we receive a request for a 20MPH we should look into it to see if we can help. Could we ask Somerset Council to collect data on our behalf, a 20MPH limit lowers the impact of a collision, survival rates are much higher at 20MPH than at 30MPH. We could use our SID (speed indicator device) to obtain data in areas of concern.
