#### The Deputy Town Clerk spoke on behalf of the resident

I have recently moved to Sea just outside Ilminster and am concerned at the speed and velocity of cars, vans and lorries that hurtle through the hamlet with no requirements to slow down at all. There is no sign to say drive carefully and as there are no street-lamps, I assume there is a speed limit of 60mph which I assure you, some vehicles reach. This is a highway used by joggers, walkers, cyclists, horse riders and the noise from the fast traffic is constant. Even Cricket Malherbie has a sign about driving considerately - there is nothing in Sea. Who do I speak to petition for action? There is actually a considerable community of people living here and nee houses have been built- we need change before someone is hurt or killed on this road.

The chair thanked the speaker for their comments. It was considered that contact should be made with Cllr Vijeh who is on the parish council for the boundary in which the road runs.

Cllr Hamilton provided the committee with an update regarding phosphates issue in the water course in the levels. There will be a new developer tool introduced for new applications and what needs to be completed to mitigate against the problem. This will be an ongoing process.

#### P393 Disabled Bay at Orchard Vale

Consideration was given to a request from a resident regarding a new disabled parking bay at Orchard Vale. The resident has an email from the Traffic Management, Road Safety and Parking Services stating that any request must have the support of the parish council.

**RESOLVED** to provide support for the application in principle but it will fall on Somerset County Council's Traffic Management and Highways Department as to whether they can locate a suitable place that is feasible for the disabled bay.

### P394 30mph signage along Station Road and Canal Way

Consideration was given to additional speed limit signage along Station Road and Canal Way. It was considered to have been a problem for several years. Additional signage on the road may be of benefit.

**RESOLVED** for the Town Clerk to contact the Highways at Somerset County Council to see if additional signage can be provided along Station Road and Canal Way.

## (b) 21/00127/HOU - Summers Orchard 3 Speke Close Ilminster Somerset TA19 9BJ

Single storey extension to south east elevation and new porch to north east elevation

Issues discussed during consideration were:

The application looks to improve the use of the building.

No other observations.

**RESOLVED** to recommend that South Somerset District Council accept the planning application.

# (c) 21/00194/HOU – Summervale Mews Wharf Lane Ilminster Somerset TA19 9BJ Erection of conservatory

Issues discussed during consideration were:

The comment raised by the neighbour regarding the soakaway was discussed. No other observations made.

**RESOLVED** to recommend that South Somerset District Council accept the application in accordance with the District Council's planning requirements for surface and run off water.

## (d) 20/03292/COU – The Old Gooch & House Building Cornhill Market Place East Street Ilminster

Change of use from B2 General Industrial to Mixed use including Class B1 - Light Industrial, Class A1 - Shops and Retail, Class A3 - Food & Drink, Class A4 - Drinking Establishments, Class A5 - Hot Food & Takeaway and Class B1 (a) & (c) - Offices/Light Industrial (Artisan/Craft Workshops).

Issues discussed during consideration were:

Some of the application is retrospective.

The new owner is trying to cover their bases as they develop the building and encompass everything.

Access to the property continues to be a problem.

Overall, the application is for general change of use.

No other observations were made.

**RESOLVED** to recommend that South Somerset District Council accept the general application for change of use.
