P60 Plans for the Cricket Pavilion

The plans for modernising the Cricket Pavilion on Wharf Lane Recreation Ground were considered before application for planning permission is submitted to South Somerset District Council.

Access path – stops on the opposite side to the ramp

- Disabled access within the building including the balcony area
- Gas pipe how is it going to be buried
- Access for contractors' vehicles temporary road / track
- Concern that the turns on the ramps will be too sharp for easy manoeuvring by wheel chair users
- Health & Safety of site and users

- Contractors using the gate by the tennis courts may mean restrictions on the public using that access point
- Need for the Cricket Club to agree to do any re-instatement before return to the IEF absolving ITC of any responsibility for costs.

- (i) That the IEF are formally approached for their permission to implement the plans
- (ii) To submit a planning application to South Somerset District Council
