Other important notes about our support:

- Accounts MUST have strong passwords. We may change passwords without notice if issues are reported.
- We usually limit full admin access to protect the integrity and security of the website. You
 edit and control all the content, however as an owner/admin we would discuss with you
 the areas you would like to retain access to.
- We take control of the DNS records for your domain name. This means we have greater control and flexibility over the security and performance features that can be used.
- Changes to areas that you don't have access to can be done by us as part of the monthly
 package at no extra cost. These areas relate to non-editable sections of the website, e.g.
 widgets, custom coding etc...
- If you decide you wish to end the agreement and move the website elsewhere we would remove any security, performance and support related software and licenses we use that are licensed to us and give back full admin access to you.

All monthly plans are paid via Direct Debit. Cancellation of the direct debit would indicate cancelling the plan.

To reduce the chance of your website being attacked and causing problems for your website and the server we can provide additional levels of protection.

To provide these we need control over the DNS records of your domain name by using our nameservers that we control.
