Review of the South Somerset Local Plan (2006 – 2028) -Issues and Options Consultation

I am writing to inform you that South Somerset District Council is reviewing the Local Plan that was adopted in March 2015; this review will cover the period 2014 to 2034.

As a first stage in the process, we are consulting on the issues and options that have emerged this far; and produced a document to stimulate debate on the best way to provide a new policy framework for planning and development in the District up until 2034. The consultation period will be from 26th October 2017 until 12 noon on 11th January 2018.

The document starts to consider the options for where new growth may go in the future; and identifies potential new sites for housing, employment and other forms of development in the various towns and villages across the District.
