Good afternoon Paul,

Thank you for the update about the planned works that you have scheduled now for September 2023.

Like Ian I am very concerned that it is intended that these works will now be taking place at the Wharf Street Carpark.

Ian has come back to you with his concerns over the siting of this chamber at this location and I can only agree that there does appear that there is viable alternative in siting the works at the Recreation Ground.

On behalf of Ilminster residents I would be interested to receive a response to the following considerations and what part they played in Wessex Water decision making process. I will need this response in order to update members of the Town Council at the Full Council Meeting on the 21 June.

- 1. Has Greenfylde School been contacted with regards:
  - a. The "Hydro-slide Chamber outside the school gates" and the issues surrounding its installation.
  - b. What consideration has been given to the fact that the school provides "Afterschool" and "Breakfast" clubs as part of their wrap around educational responsibilities from 7-45 am and 5-30 pm. This provision means there are parents dropping off and picking up in darkness during the Winter hours.
  - c. The carpark has a 15 min drop off and pick up period for parents whose children attend the school, how is this to be catered for bearing in mind that Wharf Lane is a dead end.
  - d. The safeguarding of 250 students at the start and end of the day is paramount, what provisions are being made for them?
  - e. Students from Greenfylde are also educated at the sister site Swanmead and there are regular foot movements between the two sites.
  - f. The impact of noise and other environmental issues on the daily lessons that take place both inside and outside the school?
  - g. Staff have permits to park in the carpark, what measures will be taken to ensure they have somewhere safe that they can park bearing in mind that they often arrive before dawn and leave after dusk.
- 2. As a town Ilminster is struggling to emerge economically from the Covid Pandemic and any loss of car parking in the town will have a negative impact on business recovery.
- 3. Immediately in the vicinity of the site are 32 "extra-care" housing units that will be severely affected by the works in the carpark.
- 4. Whilst not the direct concern for the Town Council, the loss of income to SSDC will not be insignificant.

I am unable following the meeting when the plan was initially brought to members, to see any support forthcoming from Ilminster Town Council for the works to take place in the car-park when there would appear to be a viable alternative site very close by. It is also clear that ward members for the Town Council as well as County Council will not support at this stage the works being sited there.

Even if we had a "PR team" I fail to see that it would find many reasons to support this location over the Recreation Ground.

I would like to extend to you, or your representative, an invitation to join the Full Council meeting on the 21 June 2022 at 7-30pm. This will then give you an opportunity to explain why this site has been considered favourable to that of the recreation ground which would preclude any of these issues occurring.

## Dear Ian, Julie & Mark

I hope you are all well and enjoyed the recent jubilee weekend. It has been a while since I have provided an update on the above scheme. Behind the scenes we have further assessed options relating to the two locations presented to you in my email dated 4th February 2022. As part of the proposed solution we need to install a hydro-slide chamber outside the entrance to Greenfylde First School. The chamber is required to control flow within the network upstream of the existing CSO (combined sewer overflow). As you know, the storage tank solution is required to reduce annual spills seen at the existing CSO.

One point discussed internally was the need to maintain/improve hydraulics within the system, it is therefore recommended that our storage tank is located as close to the hydroslide chamber as possible. With this said, our preferred location will be the car park shown within attached plan C00432-FIGURE\_0004. I understand this car park is owned by Somerset District Council. During the recent assessment, it has been noted that the storage tank volume will be reduced, this will mean that we will be able to position all new covers appropriately to ensure they are not located within the existing parking spaces.

I would be grateful if you can inform your colleagues of this and feedback any questions that may come your way. One update from my previous email is a change in start date. We had previously envisaged starting in May 2023, this has since moved and we are now looking to start in September 2023.

I would be grateful to have an opportunity to meet with you (Teams or at an office of your choice) to discuss stakeholder engagement from a PR point of view. It may be a good idea to bring your PR team in at this stage to ensure the same message is delivered.
