P437.WG Road Traffic Regulation Act 1984 – South Somerset Order 2012 – (Amendment No. 21) Order 2021 – ILMINSTER Station Road. Members were updated on the order. There were concerns raised over tickets being issued on West Street. Some discussion followed on previous Orders and that an application to have restrictions removed in 2016/2018 had been made.
