ADULT MENTAL HEALTH SERVICE PROVISION

Compass Disability Services have sub-contracted out the mental health aspect of their newly acquired contract to Somerset MIND.

CHARD HOSPITAL

No further information has been forthcoming in relation to this.

CHILDREN'S SOCIAL CARE

OFSTED recently visited SCC for their final pre-inspection monitoring visit. The focus this time was on the leaving care service and support for children with disabilities. Formal feedback is awaited and the full OFSTED inspection will take place in the autumn.

DISPOSAL OF COUNTY FARMS

At the SCC Scrutiny committee meeting, due to be held in early September, it is expected that a task and finish group be set up to review the current policy and make recommendations.

MINIBUSES

SCC operates 60 minibuses used to transport social care, special educational needs and the general public across the County, which are currently panel vans converted to minibuses with tail- lifts installed in the rear of the vehicle. Low floor minibuses are now available which comply with DDA requirements and offer access from the road level negating the need for a tail-lift and improving accessibility. These allow for greater flexibility improving access and dignity for the user and reducing health & safety risks for SCC. Individuals will be able to walk onto the bus with no large step to navigate or wheelchairs can be pushed directly into the vehicle by the carer. They will be used on SCC demand responsive, social care and special educational needs routes to enable greater flexibility within the fleet.

The proposal is to replace 10 vehicles during 2017/18 and each year thereafter in line with the business requirements already set out during the MTFP process. The cost for 2017/18 is £727,170 for the 10 vehicles (£72,717 per vehicle).

SOMERSET JOINT STRATEGIC NEEDS ASSESSMENT (JSNA) 2017 - 'AGEING WELL'

This qualitative report has recently been published www.somersetintelligence.org.uk/jsna
The summary gives an overview of the strategic health, wellbeing and social needs of Somerset people and this year has a focus on ageing well. The JSNA 2017 evidence will support the planning of services for older people and targeted preventative work to help younger people, where possible, maintain good physical and mental health into later life. Like many counties, Somerset has a growing, ageing population, and one of the key issues appears to be social contact.

COMMUNITY CONNECT

This is a partnership enabling community and voluntary organisations, Adult Social Care services and health services to work together to provide advice and support to help people live as independently as possible in their community.

Drop-ins are now taking place across the county, where people can speak to Community Agents and Village Agents, health professionals, Adult Social Care workers and community organisations, such as the Citizen's Advice Bureau, and volunteers, who will ask a few questions to find out what they are worried about, or what they would like to achieve or change in their life and will provide advice about where to find the right support or activity, or offer a suitable solution.

By working together can Community Connect aims to successfully help more people to be independent for longer. A project called 'Reviewing to Improve Lives' is looking at Learning Disability placements and support packages to make sure people are living as independently as possible and achieving their personal aspirations in life.

The Cabinet Member for Children and Families has agreed to consult in the Autumn term on a revised Education Travel Policy for SCC to apply from September 2018.

HIGHWAYS

A358 Taunton to Southfields Dualling Scheme Supplementary Consultation

The original consultation was split into two sections. Section 1 – junction B in the vicinity of West Hatch Lane. Section 2 - improvement from junction B to Southfields Roundabout. It is acknowledged that more work is needed to find the right solution for section 1, and frustration that only one option was originally put forward.

The supplementary consultation carried out this year via a series of public exhibitions. There is no further consultation planned for section 2 as highways believe that they have received clear feedback from the completed consultation, with approx. 300 consultation responses. SCC have received an application for the temporary closure of Hazelwood Hill from A Plant Lux Traffic Control from 4th Sept. for 2 nights (21.00 - 06.00hrs) to enable BT Openreach to access an underground structure for new customers connection works to be carried out.

SIS

SCC's Small Improvement Scheme has been running for 6 years, with the successful implementation of over 160 minor highway improvement schemes so far. New scheme submissions will be eligible from Sept. and I will be attending a workshop to clarify my role a County Councillor, in the application process, scoring mechanism, consultation, the delivery of schemes, and the management of stakeholder expectations.

SCC HIGHWAYS DROP-IN SESSION - ILMINSTER FLOODING

In the wake of the flooding experienced in Ilminster last month, this was organised to allow members of the public to meet with Highways and Environment Agency officers. Due to the number of premises affected, this qualifies for a 'Section 19 Investigation' into the likely causes, what needs to be done and how to take things forward. The results of the investigation will be published, along with plans for action and timescales involved and I am told that an outline report giving an indication of next steps will be made available before the end of the year. What has become clear, is that in addition to issues over drain clearance, a contributing factor is the extent that uncollected hedge and verge clippings are washed into the drainage system, along with hay falling from tractors during transportation. Since the meeting, a Highways representative has also met with Town Councillors.
