P494 Parking restrictions on West Street

Members discussed the parking restrictions on West Street. Discussions included, there are more private houses than businesses in that area now as opposed to when the original application was made in 2013. Is it something all the residents in West Street would like, and there is the potential of others parking in the spaces all day, or all weekend, and the possibility of a residents parking scheme. If there was a residents parking scheme, who would police it to ensure compliance, as parking is at a premium in Ilminster.

Members **RESOLVED** to ask the resident who sent the request to canvas the opinion of other residents and businesses in West Street to





see if they would support any changes to the parking restrictions, given that so much time has passed since the original request. **Proposer** Cllr Taylor **Seconded** Cllr Swann

P495 Planning applications

a.21/03111/FUL – Southfields Enterprise Park – Erection of a freestanding restaurant with drive-thru facility (Class E/sui generis), car parking, landscaping and associated works, including customer order displays (COD)

Members discussed the above application, discussions included, no mention of the drain off of fat. There was concern there will be more litter. A concern that cars will exit using the way in, even though it is one way, as a short cut to re-join the A303. Concerns that traffic coming from the Honiton direction on the A303 will turn right and cross the 2 lanes of oncoming traffic as a short cut as opposed to going round the Southfields roundabout.

The traffic surveys have been done before the A358 dualling program had started on the Southfields roundabout and how that will affect those surveys.

Members **RECOMMENDED** by 5 votes for and 2 against to approve the application subject to the traffic management of the A303 being reviewed.
