Member of the public 1

A local resident addressed Members regarding Agenda item 8.
The resident wanted to outline her objections to the application.

Objections included:

The disastrous impact on the town's infrastructure,
Having one entry/exit will cause chaos at peak times,
There needs to be safe and easy access to the schools,
Inadequate emergency access,
The flooding impact,
The phosphate issue,
Plus numerous other issues.

Member of the public 2

A local resident addressed Members as the applicant of Agenda items 9b and 9c.

The resident advised Members that they have been working with a conservation surveyor to update the property to make it more suitable for modern living.

Neighbours have been consulted regarding the plans.

They have been advised that they could apply to have the property delisted.

The resident advised Members that she was happy to provide any clarification when the applications were discussed.

A local resident addressed Members over his concerns regarding the grass cutting, rewilding, the cutting of hedges and the drains.

The resident advised Members that when Somerset Council cut the grass they don't collect the grass cuttings and it gets blown on to the cycle path and down the drains.

Members **NOTED** the report.
A meeting has been held between officers and representatives from Somerset Council.
Somerset Council are still in the process of putting together a map of the areas they are responsible for in Ilminster.
Somerset Council have been contacted by a local community group regarding the location of rewilding signs. The Town Council were not consulted.
It will take time to bring all the departments in Somerset Council together.
- 23-0058-PHT** **Planning Application 16/05500/OUT**
Members discussed the above application.
Discussions included,
There is a high density of homes with only one entrance/exit road.
Loss of prime agricultural land.
There are trees within the development that have TPOs on them
One of the roads leading on to the access roundabout hasn't been adopted and therefore no give way/stop signs.
Can the roundabout support the increased volume of traffic.
Point of access is a key issue, no other development of this size within the town only has one point of entry/exit.
The impact on existing services and amenities within the town eg. doctors
Can the current drainage system in Ilminster support the new housing.
The balance ponds are not adequate.
Potential for increased flooding risk within the town.
Ilminster has flooded 5 times in the last 20 years.
Further clarification is needed on phosphates credit scheme and offset mitigation rights.
Every application is discussed on its own merit.
Members requested that the application goes to committee of Somerset Council.

No provision to build a new school and no consideration for children with disabilities.

Lack of upkeep on existing developments within the town have led to areas not being adopted.

Members **RECOMMENDED** unanimously to object to the application.
