  - (ii) applications to vote by proxy must reach the Electoral Registration Officer at the address below not later than 5.00pm on TUESDAY 28th APRIL 2015.
  - (iii) applications to be treated as an emergency proxy voter at this election on the grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at the address below by 5.00pm on THURSDAY 7th MAY 2015. The physical incapacity must have occurred after 5pm on Tuesday 28<sup>th</sup> April 2015. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5.00pm on Tuesday 28<sup>th</sup> April 2015.
