As you will know, the Town Council has prepared a draft Strategic Vision for Ilminster which considers a number of ways in which members would like to see the town developing over the next 5, 10, even 20 years. The Strategic Vision is wide ranging and its implementation in many areas will be dependent on funding and indeed policy decisions which are not under our control. However it is clear that we need to generate a vision which carries wide public support, so that it can be enshrined in the development planning strategies of District and County Councils if we are to make progress in this town.
